Catchers will be instructed on stance, set-up, receiving, blocking, tags at home, plays at home, transition and throwing mechanics, and strategy in pitch calling.

Pitchers will be instructed in the mechanics of power, and pitch grips / release mechanics to enhance spin rate for increased movement.

The last segment of the camp will involve live hitting versus a pitching and a catcher.

Waiver of Liability and Release for use of Batting Cages

I acknowledge and fully understand that I, _____, the participant as listed on the front of this agreement (if participants is 18 years of age or older) or parent/legal guardian of the above listed minor participant, will be engaging in activities that may involve risk of serious injury which might result not only from my own actions, inactions, or negligence, but from the actions, inactions, or negligence of others or the conditions of the premises or of any equipment used.
